## BONDING PROPOSAL

Shall Armada Area Schools, Macomb and St. Clair Counties, Michigan, borrow the sum of not to exceed Four Million One Hundred Thousand Dollars (\$4,100,000) and issue its general obligation unlimited tax bonds therefor, for the purpose of:

acquiring, installing, and equipping or re-equipping school buildings for instructional technology; and remodeling, furnishing and re-furnishing and equipping and re-equipping school buildings?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2016, under current law, is 0 mill (\$0.00 on each \$1,000 of taxable valuation). The maximum number of years the bonds may be outstanding, exclusive of any refunding, is eight (8) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 0.73 mill (\$0.73 on each \$1,000 of taxable valuation).

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$24,295,000. The total amount of qualified loans currently outstanding is approximately \$15,917,727. The estimated computed millage rate may change based on changes in certain circumstances.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

PROPOSAL TO AMEND THE CITY CHARTER  
TO ALLOW FOR A LOCAL ROAD MILLAGE

Shall the City of St. Clair, County of St. Clair, Michigan, continue with the previously voted road debt millage currently levied at 2.4902 mills, for an additional ten (10) years and levy an additional 1.5 mills per year perpetually for a road repair and maintenance program? Both said millages will assist with necessary residential paving projects, repaving, reconstruction and improvements to rights-of-way, sidewalks, storm-water drainage facilities and all necessary appurtenances and attachments. The estimated simple average annual millage to be levied in 2016 would be 3.9902 mills (\$3.99 per \$1,000 of taxable value) and is estimated to produce an annual capture of \$753,216 for the first ten (10) years and an estimated annual capture of \$283,150 from the 1.5 mills perpetually.
