

MICHIGAN NOTARY PUBLIC

APPLICATION and INSTRUCTIONS

The application process for becoming a Michigan Notary Public involves several steps. Carefully review the instructions throughout this document to ensure successful and timely completion. For assistance, email us at MDOS-Notary@Michigan.gov.

Step by Step:

1. Fill out the application **clearly** and **completely**.
 - Use None or N/A if not applicable.
 - Use zeros for Phone numbers or Business zip code if not applicable.
2. Obtain A \$10,000.00 [surety bond](#) written for a term of six or seven years through a Michigan licensed insurance company.
3. Take the surety bond and completed application to the [county clerk's](#) office. (For a \$10.00-\$20.00 fee the Clerk will file your bond, administer an Oath and return the application to you).
4. Mail the original completed application and the \$10.00 filing fee to this office using address below; checks made payable to **State of Michigan**.
5. Look for the commission card and certificate in your email. Allow 4-6 weeks for processing. Please check all spam folders.
6. Check the status of your appointment on our [website](#). Bookmark this site to visit later. (Note, **Do not** perform notarial acts until you are listed as "Active" on this website or you have received your commission information!)
