Shall the previous voter-approved limitation of the total amount of taxes which may be assessed and levied against all real and personal taxable property in the Township of Brockway, County of St. Clair, State of Michigan of 2.0 mills (\$2.00 per \$1,000 of State taxable value), reduced to 1.8358 mills (\$1.84 per \$1,000 of State taxable value) by required millage rollbacks, be renewed at 1.8358 mills (\$1.84 per \$1,000 of State taxable value) and levied on the taxable value of all taxable property in the Township, as finally equalized, for each year for ten years, commencing in 2013 and continuing through 2022, inclusive, to provide for the enhancement of public safety services, including, but not limited to the purchase of fire trucks, firefighting equipment, and the maintenance of and improvements to the Brockway Township Fire Hall?
