TO THE QUALIFIED ELECTORS OF ST. CLAIR COUNTY:

PLEASE TAKE NOTICE that qualified electors of St. Clair County who are not already registered may register to vote at the office of their local clerk, the County Clerk's Office, a Secretary of State Branch Office or other designated state agency. To register online or to download a registration form, visit www.mi.gov/vote. Forms should be mailed **directly** to your **LOCAL CLERK** as shown below. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, Oct 21, 2024**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at their local clerk's office as shown below during the following times:

- **PLEASE TAKE NOTICE** that the following partisan offices will appear on the ballot: U.S. President/Vice President, U.S. Senator, U.S. Representative in Congress, State Representative, State Boards, all County Offices, all County Commissioners, City of Yale offices, all Township offices. The following non-partisan offices will also appear on the ballot: Judicial Offices, School Boards, and the following city offices: City of Algonac, Marine City, City of Marysville, City of Memphis, City of Port Huron, City of Richmond, and City of St Clair.
- **PLEASE TAKE NOTICE** *China Township electors* will be voting on a new millage of 1.00 mill for a period of four (4) years for the purpose of providing road and ditch maintenance and improvements.
- **PLEASE TAKE NOTICE** *Kenockee Township electors* will be voting on a proposal to authorize the township board of trustees to amend the code of ordinances to permit the production and/or sale of marihuana.
- **PLEASE TAKE NOTICE** *Lynn Township electors* will be voting on a renewal millage of 1 mill for the period of 2024 through 2027 for the purpose of construction, improvement and maintenance of public roads.
- **PLEASE TAKE NOTICE** *Marine City electors* will be voting on five (5) Charter Amendments: (1) Proposed amendment to sec. 3.3 to the charter of the city of Marine City relating to the compensation of city commission members and the city mayor. (2) Proposed amendment to sec. 3.11 to the charter of the city of Marine City. (3) Proposed amendment to add sec. 3.20 to the charter of the city of Marine City. (4) Proposed amendment to sec. 5.4 to the charter of the city of Marine City. (5) Proposed amendment to chapter 13 to the charter of the city of Marine City.
- **PLEASE TAKE NOTICE** *City of Yale electors* will be voting on three proposals: 1) a proposal for a continuation millage increase of 2.9781 mills for law enforcement purposes for a period of six (6) years. 2) a millage renewal of 1.5 mills for a period of five (5) years for the purposes of maintaining, improving, repairing, replacing and/or constructing streets and sidewalks, including drainage. 3) a proposal for a renewal millage of 0.25 mills for a period of five (5) years for the purpose of maintaining, improving, repairing, replacing and/or constructing sidewalks in the City of Yale.
- **PLEASE TAKE NOTICE** *Almont Community Schools electors* will be voting on Almont Community School sinking fund millage proposal 2 mills for five (5) years.
- **PLEASE TAKE NOTICE** *East China School District electors* will be voting on East China School District sinking fund millage proposal 2.75 mills for ten (10) years.
- **PLEASE TAKE NOTICE** *Marysville Public School electors* will be voting on a school improvement bond proposition to borrow the principal sum of not to exceed \$18,500,000.
- **PLEASE TAKE NOTICE** *Memphis Community Schools electors* will be voting on a Memphis Community Schools general obligation unlimited tax bond proposal for building and site purposes in the amount of not to exceed \$16,200,000.
